Ministerial Regulation

No. 4 B.E. 2522 (1979)

Issued pursuant to the Food Act B.E 2522 (1979)

-----

By the virtue of Section 5, Section 22, Section 31, and Section 36 of the Food Act B.E. 2522 (1979), the Minister of Public Health hereby issues a Ministerial Regulation as follows :

Clause 1 Licensees of food production factory for sale or licensees of food importation for sale whom desire to apply for registration of specific controlled food, submit Form Orr. 17 attached to this regulation together with four copies of documents as indicated in Form Orr.17.

There is additional clause as Clause 1 bis by Clause 1 of Ministerial Regulation No. 7 (B.E.2525)(1982), afterwards Clause 1 bis is repealed by Clause 1 of Ministerial regulation No.9 (B.E. 2526) (1983).

Clause 2 Form Orr.18 attached to this regulation is used for Certificate of Food Recipe Registration.

Clause 2 is repealed and is replaced by Clause 2 of Ministerial Regulation No.7 (B.E.2525) (1982) and No. 9 (B.E. 2526) (1983).

Clause 3 An Acceptor of Food Recipe Registration Certificate, whom desires to amend the registered food recipe, submits Form Orr. 19 attached to this Regulation including with the certificate that need to be amended.

An approval for amendment of a registered Food Recipe, a licenser may indicate in that certificate or may issue a new certificate or may notify by a letter of approval.

Having additional Clause as Clause 3 bis by Clause 3 of Ministerial Regulation No.9 (B.E. 2526) (1983).

Clause 4 An Acceptor of Food Recipe Registration Certificate, whom desires to apply for a Substitute, submits Form Orr. 20 attached to this Regulation including with documents indicated in Form Orr.20.

An approval for the Substitute, licenser shall issue the same kind of the former certificate but the word "Substitute" shall also be indicated on the front page.

Clause 5 An Application according to this regulation can be submitted at Division of Food Control, Food and Drugs Administration Ministry of Public Health, for other provinces beside Bangkok Metropolitan, can be submitted at Provincial Public Health office in that province.

Remark: Reasons to issue this regulation are due to Section 22, Section 31, and Section 36 of the Food Act B.E. 2522(1981) enact that an application for food recipe registration, Amendment of list of the recipe and an approval for an amendment including application and approval for a substitute shall be complied with the principles, procedures and provisions indicated in the regulation, it deems necessary to issue this Ministerial Regulation.
