Ministerial Regulation

No. 12 (B.E.2548) (2005)

Issued pursuant to the Food Act B.E 2522 (1979)

By the virtue of provisions of Section 5, Section 14, Section 18 and Section 21 of the Food Act B.E. 2522 (1979), in which contain provisions in relation to the restriction of Rights and Liberties of the Persons, in respect of which Section 29 and in conjunction with Section 35, Section 39, Section 48 and Section 50 of the Constitution of the Kingdom of Thailand so permit by virtue of provisions of law; the Minister of Public Health hereby issues the Ministerial Regulation as follows:

Clause 1 Add the following wordings as Clause 2/1 of the Ministerial Regulation No.1 (B.E.2522)(1979) issued pursuant to the Food Act B.E 2522 (1979).

“Clause 2/1 The licensee according to clause 1 whom produce the food which the Minister prescribe Production Processes, Production Equipments, and storage of such food according to clause 6(7) shall pass the assessment that the Minister prescribed ; such assessment shall be complied with principles prescribed by the Secretary-General of Food and Drug Administration”

Clause 2 The following wordings shall be added to Paragraph 3 of the Ministerial Regulation No.1 (B.E.2522)(1979) issued pursuant to the Food Act B.E 2522 (1979).

“For Renewal of a Food Production License which the Minister prescribed Production Processes, Production Equipments, and storage of such food according to clause 6(7), allow to enforce by wordings in Clause 2.1 mutatis mutandis unless other documents are prescribed by the Secretary General of Food and Drug Administration “

Clause 3 Shall be repealed wordings of Paragraph 3 of the Ministerial Regulation No.1 (B.E.2522)(1979) issued pursuant to the Food Act B.E 2522 (1979) and shall be replaced by the following wordings :

“For Relocating of Food Production or Food Holding establishments allow to enforce by wording of Clause 2 and Clause 2/1 mutatis mutandis”

Clause 4 Shall be repealed wordings of Clause 8 of the Ministerial Regulation No.1 (B.E.2522)(1979) issued pursuant to the Food Act B.E 2522 (1979) and shall be replaced by the following wordings :

“Clause 8 The Application according to this Regulation can be submitted at the following places:

(1) Bangkok Metropolitan ; at the office of Food and Drug Administration, Ministry of Public Health or other places that Secretary-General of Food and Drug Administration prescribed.

(2) Other provinces ; at the office of Food and Drug Administration, Ministry of Public Health or Provincial Public Health offices which such factory located or other places that Secretary-General of Food and Drug Administration prescribed”
