It deems appropriate to amend the control measures on palm oil.

By the virtue of provisions of Section 5 and 6 (1) (2) (4) (5) (7) and (10) of the Food Act B.E. 2522 (1979), the Minister of Public Health hereby issues a notification as follows:

Clause 1. Additional expression to Phrase 2 of Clause 1 in the notification of the Ministry of Public Health No. 56 B.E. 2524 (1981), Re: Palm oil, dated 20th January B.E. 2524 (1981).

"Palm oil as stipulated in first phrase is not to include palm oil, which is required proper procession prior to be consumed, shall indicate clearly that not for consumption purpose."

Clause 2. The expression in Clause 7 of the notification of the Ministry of Public Health No. 56 B.E. 2524 (1981), Re: Palm oil dated 20th January B.E. 2524 (1981), shall be repealed.

Clause 3. Food Registration or Food labelling that follow to the notification of the Ministry of Public Health No. 56 B.E. 2524 (1981), Re: Palm oil dated 20th January B.E. 2524 (1981), for other use of palm oil except for consumption, which are issued prior to this notification, shall be repealed.

This notification shall come into force as from the day following date of its publication in the Government Gazette.

## Announcement of The Food and Drug Administration

Re: Clarification of the notification of the Ministry of Public Health, Re: Palm Oil (No. 2)

According to the notification of the Ministry of Public Health No. 56 B.E. 2524 (1981), Re: Palm Oil, which including to palm oil, for other use beside consumption or food preparation, must indicate "Not for consumption" on the labels of the containers in red alphabets of size not smaller than 1 centimeter on a border of white background. The labels shall be submitted for approval from the Food and Drug Administration prior to be used. Since palm oil, which are not intended for consumption in food industry and to reduce steps to follow to regulations for such palm oil, the Ministry of Public Health hereby issues the notification (No. 184) B.E. 2542 (1999), Re: Palm Oil (No. 2) as follows:

- Clause 1. Palm oil, for other use beside consumption or food preparation, shall not be included in the notification of the Ministry of Public Health, Re: Palm Oil.
- Clause 2. The expression in Clause 7 of the notification of the Ministry of Public Health No. 56 B.E. 2524 (1981), Re: Palm Oil dated 20th January B.E. 2524 (1981), shall be repealed.
- Clause 3. The Food Registration or Food Labelling of palm oil, for other use besides consumption or food preparation, which is issued to follow the notification of the Ministry of Public Health No. 56 B.E. 2524 (1981), Re: Palm Oil dated 20th January B.E. 2524 (1981), prior to this notification come into force, shall be repealed.

This notification of the Ministry of Public Health is published in the Government Gazette Vol. 116, Part 41 Ngor, dated 25th May B.E. 2542 (1999) and shall come into force on 26th May B.E. 2542 (1999).
