Notification of the Ministry of Public Health
(No. 284) B.E. 2547 (2004)
Re: Drinking Water in Sealed Containers (No.5)

Due to at present drinking water is food required to have to control of production premise in accordance with the standards specifically prescribed in the Notification of the Ministry of Public Health Re: Production Processes, Production Equipments and Food Storages, it deems appropriate to revise the control measure for drinking water in sealed containers to suit the current situation.

By the virtue of provisions of Section 5 and 6(3) (6) (7) and (10) of the Food Act B.E. 2522 (1979), in which contain provisions in relation to the restriction of Rights and Liberties of the Persons, in respect of which Section 29 and in conjunction with Section 35, Section 39, Section 48, and Section 50 of the constitution of the Kingdom of Thailand so permit by virtue of provisions of law; the Minister of Public Health hereby issues the notification as follows:

Clause 1. The expression in Clause 2 of the Notification of the Ministry of Public Health No. 61 (B.E. 2524) Re: Drinking Water in Sealed Containers date 7th September B.E. 2524 shall be repealed and replaced with this following expression:

“Clause 2. Drinking water in sealed containers shall be food prescribed to have qualities or standards.”

Clause 2. Manufacturers and importers of drinking water who have received Food Registration or Food Labelling according to the Notification of the Ministry of Public Health No. 61 (B.E. 2524) Re: Drinking Water in Sealed Containers dated 7th September B.E. 2524 and the Notification of the Ministry of Public Health No. 135 (B.E. 2534) Re: Drinking Water in Sealed Containers (No.2) dated 26th February B.E. 2534 and the Notification of the Ministry of Public Health No.220 (B.E. 2544) Re: Drinking Water in Sealed Containers (No.3) dated 24th July B.E. 2544 and the Notification of the Ministry of Public Health No. 256 (B.E. 2545) Re: Drinking Water in Sealed Containers (No. 4) dated 30th May B.E. 2545 which were issued prior to the date this Notification comes into force, shall continue to use the received Food Serial Number, as if it was recorded or declared in accordance with this Notification.

Clause 3. This notification shall come into force as from the day following date of its publication in the Government Gazette.
