Notification of the Ministry of Public Health Re: Drinking Water in Sealed Containers (No. 6).

It deems appropriate to amend the Notification of the Ministry of Public Heath; Re: Drinking water in sealed containers

By the virtue of provisions of Section 5 and 6 (3) (6) (7) and (10) of the Food Act B.E. 2522 (1979), in which contain provisions in relation to the restriction of Rights and Liberties of the Persons, in respect of which Section 29 and in conjunction with Section 33, Section 41, Section 43 and Section 45 of the Constitution of the Kingdom of Thailand so permit by virtue of provisions of law; the Minister of Public Health hereby issues the notification as follows:

Clause 1. Text in (s) of (2) of Clause 3 of the Notification of the Ministry of Public Heath; Re: Drinking water in sealed containers dated 7th September B.E. 2524 (1981) shall be repealed and replaced with the following texts;

"(s) Fluoride calculated as fluorine not more than 0.7 milligram per 1 liter of water"

Clause 2. Text in Clause 1 that specify fluoride not more than 0.7 milligram per 1 liter of water will not be applied to water used in food processing and water vapor which contact with food in processing;

Water in food processing and water vapor which contact with food in processing shall have fluoride calculated as fluorine not more than 1.5 milligram per 1 liter of water.

Clause 3. Manufacturers, Importers of Drinking Water in sealed containers that registered detailed of food according to the Notification of the Ministry of Public Heath (No. 61) (B.E.2524) (1981); Re: Drinking water in sealed containers dated 7th September B.E. 2524 (1981) which was amended by the Notification of the Ministry of Public Health (No. 135) (B.E.2534) (1991); Re: Drinking water in sealed containers (No.2) dated 26th February B.E. 2534 (1991), the Notification of the Ministry of Public Health (No.220) (B.E.2544) (2001); Re: Drinking water in sealed containers (No.3) dated 24th July B.E. 2544 (2001), the Notification of the Ministry of Public Health (No.256) (B.E.2545) (2002); Re: Drinking water in sealed containers (No.4) dated 30th May B.E. 2545 (2002) and the Notification of the Ministry of Public Health (No.284) (B.E.2547) (2004); Re: Drinking water in sealed containers (No.5) dated 10th November B.E. 2547 (2004) prior to the date of this Notification come into force shall follow this Notification within 90 days as from the date of this notification come into force.

Clause 4. This notification shall come into force as from the day following date of its publication in the Government Gazette.
