(Unofficial) Notification of the Ministry of Public Health B.E. 2553 (2010)

Re: Amendment of the Notification of the Ministry of Public Health (No. 193) B.E. 2543 (2000) (No.2)

It deems appropriate to amend the notification of the Ministry of public Health, Re: Production Processes, Production Equipments, and Foods Storages.

By the virtue of provisions of Section 5 and 6 (7) of the Food Act B.E. 2522 (1979), in which contain provisions in relation to the restriction of Rights and Liberties of the Persons, in respect of which Section 29 and in conjunction with Section 33, Section 41, Section 43 and Section 45 of the Constitution of the Kingdom of Thailand so permit by virtue of provisions of law; the Minister of Public Health hereby issues the notification as follows:

Clause 1. The following texts shall be added as (58) (59) (60) and (61) in Clause1 of Notification of the Ministry of Public Health (No. 193) B.E. 2543 (2000); Re: Production Processes, Production Equipments, and Foods Storages;

- "(58) Ready to cook food which ingredients are prepared and clearly separated as a set in one packaging for cooking a particular food;
 - (59) Bakery product
- (60) Meat products other than Meat products as defined in Notification of the Ministry of Public Health (No.243) B.E.2544 (2001); Re: Some Meat Products.
 - (61) Rice noodle and rice vermicelli"

Clause 2. The following texts shall be added as Clause 2/1 of Notification of the Ministry of Public Health (No. 193) B.E. 2543 (2000); Re: Production Processes, Production Equipments, and Foods Storages dated 19^{th} September B.E. 2543 (2000) .

"Clause 2/1 Audit of Production Processes, Production Equipments, and Foods Storages shall be followed stipulation made by the Secretary General of The Food and Drug Administration with an approval by the Food Committee".

Clause 3. Person who have received licenses for production or production establishment numbers or import licenses; as a case may be, under Clause 1 (58) (59) (60) and (61) of Notification of the Ministry of Public Health (No. 193) B.E. 2543 (2000); Re: Production Processes, Production Equipments, and Foods Storages dated 19th September B.E. 2543 (2000) that is amended by this Notification , prior to this Notification come into force and have not followed to Clause 2 and Clause 3 of Notification of the Ministry of Public Health (No. 193) B.E. 2543 (2000); Re: Production Processes, Production Equipments, and Foods Storages dated 19th September B.E. 2543 (2000), modification, correction or providing for certificate shall be made to follow this Notification within two years after the date of this Notification comes into force .

Clause 4 This Notification shall come into force after 180 days following date of its publication in the Government Gazette, except for text in Clause 2 shall come into force the following date of its publication in the Government Gazette.
