Notification of Ministry of Public Health

Re: Electrolyte beverage (No. 2)

It deems appropriate to amend the notification of the Ministry of Public Health, Re: Food for weight control person concerning yeast and mold for more suitable requirements.

By the virtue of provisions of Section 5 in the first phrase, and 6 (3) and (9) of the Food Act B.E. 2522 (1979), in which contain provisions in relation to the restriction of Rights and Liberties of the Persons, in respect of which Section 29 and in conjunction with Section 33, Section 41, Section 43 and Section 45 of the constitution of the Kingdom of Thailand so permit by virtue of provisions of law; the Minister of Public Health hereby issues the notification as follows:

Clause 1. Text in (e) of Clause 5 of the Notification of the Ministry of Public Health (No.195) B.E. 2543 (2000), Re: Electrolyte beverage, dated 19th September B.E. 2543 (2000) shall be repealed and replaced with the following text:

“(e) Detected yeast and mold shall be as follows:

1) less than 1 in 1 milliliter of electrolyte beverage which pass through sterilization or UHT;

2) less than 10 in 1 milliliter of electrolyte beverage which pass through process other than sterilization or UHT;

Use Updated version of Bacteriological Analytical Manual (BAM) Online U.S. Food and Drug Administration or equivalent method as Method of analysis of such yeast and mold”.

Clause 2. Text in phrase 2 of Clause 4 of the Notification of the Ministry of Public Health (No.195) B.E. 2543 (2000), Re: Electrolyte beverage, dated 19th September B.E. 2543 (2000) shall be repealed and replaced with the following text:

“Moisture content of dried electrolyte beverage shall not be more than 5 percent by weight; detected yeasts and molds shall not be more than 100 in 1 gram of electrolyte beverage and when dilute or mix with water according to direction on its label, quality or standards shall be as in clause 4 (1) (2) (3) (4) (5) (a) (b) (c) and (d) (6) (7) (8) and (9)

Use Updated version of Bacteriological Analytical Manual (BAM) Online U.S. Food and Drug Administration or equivalent method as Method of analysis of such yeast and mold”.

Clause 2. This notification shall come into force as from the day following date of its publication in the Government Gazette.
