Notification of the Ministry of Public Health

(No. 404) B.E. 2562

Issued by virtue of the Food Act B.E. 2522

Re: Food seasonings derived from the hydrolysis or fermentation of soybean protein (No.3)

It deems appropriate to amend the Notification of the Ministry of Public Health, Re: Food seasonings derived from the hydrolysis or fermentation of soybean protein.

By the virtue of provisions of Section 5 in the first phrase, and 6(3) (4) (5) (6) (7) and (10) of the Food Act B.E.2522 (1979), the Minister of Public Health hereby issues the notification as follows:

- **Clause 1.** Clause 9 of the Notification of the Ministry of Public Health Re: Food seasoning derived from the hydrolysis or fermentation of soybean protein dated 6th May B.E. 2553 (2010), shall be repealed and replaced with the following texts
- "Clause 9 Labeling of food seasoning derived from hydrolysis or fermentation of soybean shall follow the Notification of the Ministry of Public Health; Re: Labeling of Prepackaged Foods and the following particulars shall be declared as the case maybe;
- (1) Food seasoning derived from the hydrolysis or fermentation of soybean protein contained edible salt as an ingredient and iodine added in the production process or food seasoning derived from the hydrolysis or fermentation of soybean protein used iodized salt as an ingredient as the case maybe, shall declare messages as follows:
- (1.1) If it contained with edible salt as an ingredient and iodine added during the production process, the following statement shall be declared "Iodine.....mg per l" or "Use of iodine as an ingredient" or "Iodine added" in a prominent position.
- (1.2) If it contained with iodized salt used as an ingredient, one among the following statements shall be declared:
- 1.2.1 "Edible salt fortified with iodine.........%" or "Iodine fortified salt......%" or "Iodized salt......%" in the food recipes; or
- 1.2.2 "Use edible salt fortified with iodine" or "Use iodine fortified salt" or "Use iodized salt" or "Mixed with edible salt fortified with iodine" or "Mixed with iodine fortified salt" or "Mixed with iodized salt" at a prominent position

All this, varieties of salt such as "sea salt" or "rock salt" may be specified together with such statements"

Clause 2. This notification shall come into force as from the day following the date of its publication in the Government Gazette
