Notification of the Ministry of Public Health

(No. 405) B.E. 2562

Issued by virtue of the Food Act B.E. 2522

Re: Food supplement (No.3)

It deems appropriate to amend the notification of the Ministry of Public Health, Re: Food supplement

By the virtue of provisions of Section 5 in the first phrase, and 6(3) (4) (5) (6) (7) and (10) of the Food Act B.E.2522 (1979), the Minister of Public Health hereby issues the notification as follows:

Clause 1. Clause 4 of the Notification of the Ministry of Public Health (No 293) B.E. 2548 Re: Food supplement dated 15th December B.E. 2548 (2005), shall be repealed and replaced with the following texts

"Clause 4 Food supplement are prescribed to be the food subject to have the qualities or standards."

Clause 2 . Clause 9 and Clause 10 of the Notification of the Ministry of Public Health (No. 293) B.E. 2548 Re: Food supplement dated 15th December B.E. 2548 (2005) and amended the Notification of the Ministry of Public Health (No. 309) B.E. 2550 Re: Food supplement (No. 2) dated 7th November B.E. 2550 (2007) , shall be repealed and replaced with the following texts

"Clause 9 Labeling of food supplement shall follow the Notification of Ministry of Public Health, Re: Labeling of Prepackaged Foods and the following particulars shall be declared as the case maybe

- (1) Names of food by having the text of "food supplements" as a part of the name, or accompanied with;
- (2) Quantity of the packed food supplement shall be expressed as the case may be, as follows:
- (2.1) Food supplement in form of tablets or capsules expressed as the number per pack.
 - (2.2) Food supplement in form of liquid expressed as net volume.
- (2.3) Food supplement in form of solid or others expressed as net weight.
- (3) Name and quantity of main ingredients of food supplement and constituents which claims for usefulness, in descending orders on the label of food supplement

Clause 10 Warning or other statements of food supplement as in the annex to this Notification"

Clause 3. This notification shall come into force as from day following the date of its publication in the Government Gazette
