Ministerial Regulation

No. 3 B.E. 2522 (1979)

Issued pursuant to the Food Act B.E 2522 (1979)

-----

By the virtue of Section 5 and Section 16 of the Food Act B.E. 2522 (1979), the Minister of Public Health hereby issues a Ministerial Regulation as follows :

Clause 1 Those who intend to apply for

(1) Temporary production of food, submit an Application Form as Form Orr.11 attached with this regulation.

(2) Temporary importation of food, submit an Application Form as Form Orr.12 attached with this regulation.

Clause 2 License:

(1) Of temporary production of food, Form Orr. 13 attached with this regulation shall be used.

(2) Of temporary importation or ordering of food, Form Orr. 14 attached with this regulation shall be used.

Clause 3 Those who intend to apply for

(1) Production or Exportation of food to be a sample or to register for food recipe or to consider for purchasing order, Form Orr.15 attached with this regulation shall be submitted and also enclosed with documents specified in Form Orr.15.

(2) Importation of food to be a sample for Registration of Food recipe Form Orr.16 attached with this regulation shall be submitted and also enclosed with documents specified in Form Orr.16.

Clause 4 Status of the Permission according to Clause 3, shall be indicated in Form Orr. 15 or Form Orr. 16, as the case may be.

Clause 5 Submission of the Application according to the regulation can be done at Division of Food Control, Food and Drugs Administration Ministry of Public Health, for other provinces beside Bangkok Metropolitan, can be done at Provincial Public Health offices in that province.

Remark: Reasons to issue this regulation are due to Section 16 of the Food Act B.E. 2522(1979) enact that food producers or importers of temporary importation of food who have temporary license from licenser and produce food or importation or exportation of food to be a sample for Food Recipe Registration or for consideration to purchase are exempt from an application for food production license or food importation license to sell according to Section 14 or Section 15 of the Food Act B.E. 2522(1979) but shall implement according to the principles, procedures and provisions indicated in the regulation, it deems necessary to issue this Ministerial Regulation.

**Note:** This English version of the notification is translated to meet the need of the non-Thai speaking people. In case of any discrepancy between the Thai original and the English translation, the former will take priority.
