Ministerial Regulation

No. 9 (B.E.2526) (1983)

Issued pursuant to the Food Act B.E 2522 (1979)

---

By the virtue of provisions of Section 5, Section 31 and Section 36 of the Food Act B.E. 2522 (1979), the Minister of Public Health hereby issues the Ministerial Regulation as follows:

Clause 1 Shall be repealed wordings of Clause 1 bis of Ministerial Regulation No.4 (B.E. 2522) (1979) issued pursuant to the Food Act B.E. 2522 (1979) which is amended by Ministerial Regulation No.7 (B.E. 2525) (1982) issued pursuant to the Food Act B.E. 2522 (1979).

Clause 2 Shall be repealed wordings of Clause 2 of Ministerial Regulation No.4 (B.E. 2522) (1979) issued pursuant to the Food Act B.E. 2522 (1979) which is amended by Ministerial Regulation No.7 (B.E. 2525) (1982) issued pursuant to the Food Act B.E. 2522 (1979) and shall be replaced as follows:

“Clause 2 Application Form according to Clause 1 for Certificate of Food Recipe Registration; Form Orr. 18 attached with this regulation shall be submitted.”

Clause 3 Add the following clause as Clause 3 bis of Ministerial Regulation No.4 (B.E. 2522) (1979) issued pursuant to the Food Act B.E. 2522 (1979).

“Clause 3 bis For the benefit of exportation, in case of licensees of food production factory set up for sale whom received a certificate of food recipe registration and have necessitate to use label as required by its customers, the licensees can use such label when they submit to licensor a letter of reason together with sample of the labels to examine at Division of Food Control, Food and Drugs Administration Office, Ministry of Public Health; when the licensor received the letter if an unapproved letter has not been issued by the licensor within 30 days from the day of receiving that letter and label sample; permission to use such label for exportation is allowed to the licensee.

In case of the licensee give reason together with the sample of labels according to Clause 1 by submit to Provincial Public Health Offices, Provincial Public Health Offices pass the letter together with the label sample to the Licensor within 2 days since the date of receiving the letter and label sample from the licensees.

Remark : Reason to issue this Ministerial Regulation is due to promote and facilitate the licensee of food production factory setup for sale and desire to export the special control food which has been registered for former food recipe it deems appropriate to amend Ministerial Regulation No.4 (B.E.2522)(1979) issued pursuant to Food Act B.E.2522 (1979) which was amended by Ministerial Regulation No.7 (B.E. 2525)(1982) issued pursuant to Food Act B.E.2522 (1979) by repeal the requirement of such licensees shall apply for new food recipe and require the licensees shall submit the letter of reasons including with label sample attached to the licenser to examine therefore it is necessary to issue this Ministerial Regulation.
