No. 5 (B.E.2522) (1979)

Issued pursuant to the Food Act B.E 2522 (1979)

By the virtue of provisions of Section 5 of the Food Act B.E. 2522 (1979), the Minister of Public Health hereby issues the Ministerial Regulation as follows:

	and more or power is equivalent up to 50 horsepower and more	per license
(7)	A License of Importation or Purchasing of food into the	15,000 baht
